

MINISTER'S REPORT

Dear Friends

As I look back over the year, 2021, I see multiple times when we as a community of faith thought we had seen the "light at the end of the tunnel". Restrictions loosened as COVID infection numbers diminished, more in-person gatherings happened inside



the church, we could sing, we could talk to one another (albeit with masks and distancing), we pray together. And then...the light ended up being a little further away than we imagined or hoped for. I have felt those ups and downs, some of you would even call me, on those hard days and visit me on those good days, just to let me know how you were doing. I appreciated the confidence you had in me, that you trusted my presence in your life, even if I really had nothing to offer but my time.

In previous Annual Reports I have highlighted two or three or four or five persons whom I felt had made extraordinary efforts to keep our community healthy, vital and connected. As I have prayed over this report there was one name I wanted to share, David Rackham. Many volunteers, staff members, have worked hard, used our spiritual imaginations, and offered deep care for one another. The names are legion. But as he comes to the end of his term of office, serving even an extra year, as Chair of the Executive Board, I want to say a few words about David. Despite poor health, despite having only moved back to Halifax with Zenora less than a decade ago after 28 years teaching in Japan, despite being told the role would a ceremonial one, David discovered the work of being our leader to be challenging, rewarding, and even by times, "soul-uplifting". Whenever I would ask David about his health or the challenges he carried, he would smile and say, "We must carry on, bravely." And he did.

David shepherded us through our building renovation choices, he helped reestablish our connections with the UCC, he made himself available to listen to anyone on any of our governance committees, at any time. And when staff would end another year in service to the church, we would all receive a beautiful letter of thanks from David. Persons going through hard times would sit with David, usually long after coffee hour had ended in the Hall. David led by example; he was a witness to the words he spoke.

This has been a most challenging year. And I am grateful to so many of you for your active participation in this community. We were all privileged to go through it together, with the wise leadership of our friend David.

ANNUAL GENERAL MEETING (AGM) held via ZOOM

Executive Board Report

Each governance board and committee of Bethany United Church has its specific mandate and area of jurisdiction, and the Executive Board (EB) is no exception in this regard. Generally speaking, the EB is responsible for exercising "overall" leadership in the care and oversight of the spiritual life, activities and the work of the congregation, the care and maintenance of church property and facilities, and acts as a liaison between our local Community of Faith and Regional Council 15 of the United Church of Canada. Various specific boards and committees such as the Board of Managers, the Board of Trustees, the Session, and the Outreach Committee, among many others, take care of the day-by-day management and governance of the activities of Bethany United Church. Their reports may be found elsewhere in this Annual Report 2021, but all have representation on the EB.

In receiving and disseminating reports from the various boards and committees that comprise the governance framework (polity) of Bethany United Church, the EB, as the most widely representative body of the congregation, also serves the important function of keeping people informed of the ongoing activities, opportunities and challenges faced by the Bethany community as it seeks to be an instrument of God's kingdom here on Earth.

The COVID-19 pandemic began around March-April 2020 and continues to this day with the Omicron variant of the SARS CoV-2 virus in full ascendancy. The first full year of the pandemic was 2021 and it was a year of alternating hopes raised and hopes dashed as the pandemic at times seemed to offer a gateway to some semblance of normalcy only to withdraw that offer as new variants emerged that required the provincial health authority to alternately strengthen virus mitigating protocols and then relax them as the epidemiology warranted. As the Christmas season approached, there was hope that we could offer some degree of Bethany's traditional Christmas events, but then came the highly transmissible Omicron variant that forced us to take a step backward into the virtual realm with You-Tube streaming of these important annual celebrations. As 2021 came to an end, we were facing an uncertain future but still with hope that 2022 would prove to be a more normal year at Bethany in due course.

During 2021 the Executive Board met on an "as needed" basis and all meetings were held via the ZOOM platform. With the establishment of a Working Group to establish protocols for a return to in-person services, routines were established and implemented allowing a partial return to in-person services supplemented by live streaming of such services and the availability of such services to congregants on demand at their convenience via Bethany's You-Tube channel. Later in the year as government mandates were adjusted, a sub-committee of that working group was established to determine how Bethany would deal with a potential "proof of vaccination" policy for those wishing to attend in-person Sunday services and other activities held at Bethany.

As it turned out, faith services were classified by the government as "essential" services and therefore exempt from the "proof of vaccination" requirement. However, the result of a survey conducted by the sub-committee determined that a very high percentage of respondents wanted Bethany to implement a "proof of vaccination" protocol so the decision to comply with that request was taken. Toward the latter part of 2021, attendance at in-person services under the "proof of vaccination" protocol was continuing to increase until Omicron struck in December 2021 bringing Bethany back to the virtual world of live steaming with no congregants in attendance other than via the virtual medium.

In short, the Executive Board was largely in a holding pattern throughout 2021, making sure that Bethany staff and congregants and others making use of the facilities were operating in an environment as safe as humanly possible in respect to transmission of the virus. Apart from COVID-related protocols, other business of the Executive Board included approval of a one-year trial of a Managed Portfolio as proposed by the Board of Trustees. Oversight of the Option 1 renovation project continued, the EB having delegated to the Board of Managers the actual implementation of the project. The EB also approved renovations to the kitchen and certain funds to partially cover the cost of this project. The EB also approved the appointment of a new treasurer, Rob Steeves, who generously agreed to accept that role upon the retirement of Linda Knechtel who served Bethany so ably as treasurer and in many other capacities over recent years.

As chair of the EB, I prepared several letters for the congregation during the course of the year explaining what steps we were taking to deal with the COVID pandemic and why these steps were necessary. I am most grateful that members of the Bethany family have been willing to comply with these disruptive, albeit necessary, changes to our procedures in order to sustain the Bethany community as best we could. That Bethany was not only able to survive but also prosper to a degree throughout 2021 even in the face of great uncertainty is a testament to how important our community is in the lives of so many of its members. The due diligence of so many people, staff members and volunteers and parishioners at large have made this possible and the EB is deeply grateful for the support received throughout the year.

As this is my final annual report to the congregation in the role as EB chair, I want to take this opportunity to acknowledge a number of people who played particularly important roles in sustaining Bethany throughout 2021. First and foremost is our minister, Rev. Kevin C. Little, whose tireless efforts in so many domains have been essential to sustaining the viability of our congregation. His dedication to duty well beyond any formal call of duty is truly legendary. As chair of the EB, I have been blessed to work with Kevin over the years. He was always available if I felt the need of advice as impending decisions had to be taken. Many of you have been recipients of his kindness and support in difficult times. If you knock or call, you can have every expectation that

the door will be opened almost at any time of the day or night. How fortunate we are to have Kevin shepherding us through the vicissitudes of these perilous pandemic times.

In addition to Kevin, our staff members (Shawn Whynot, Ann Bradley, Dana Mills, Louisa Duck, Jimmy Sweet and Tina Gascon) have offered yeoman service to Bethany throughout 2021. Each of them played an essential role in sustaining our community and we are deeply grateful to each of them as they continue to go well beyond any formal call of duty in support of Bethany. I wrote to each of them at Christmas time expressing on your behalf our deep gratitude for their presence and service among us. How could we have managed without them?

Where would we be without the Bethany Audio-Visual Ministry team consisting of Barry Paton, Glen Knapp, Rob Steeves, Penny Allen, and other volunteers who have filled in as time and circumstances required. Through the efforts of this team, live streaming has become a regular part of the media by which Bethany communicates with its parishioners and the world beyond. Their diligence in perfecting this medium has allowed us to maintain a sense of community and continuity which, otherwise, might have been significantly compromised under the pandemic onslaught we have been enduring as individuals and as a community.

I would be deeply remiss if I failed to acknowledge the enormous contribution Linda Knechtel has made to Bethany throughout 2021, not only in the strategic role of treasurer, but in many other capacities as well including serving as a member and chair of the Working Group mentioned above and the sub-committee of that group and the implementation of our in-person Sunday services when we were able to hold them. Along with Pam Carter and others, they made it possible to hold meaningful in-person services even under the constraints of COVID-19 protocols.

To all those volunteers who, by virtue of their commitment to the cause, transform the Christian ideals of Bethany into reality, we owe an enormous debt of gratitude. Bethany simply couldn't function without you. Each of you is a special blessing to our community. Working together as you do, bringing your gifts of talent and time to bear on the task of building the Kingdom of God on Earth in the here and now, the whole becomes much bigger than the sum of its individual parts, and great things become possible.



of events. My prayer is that you will extend to that new leadership the kind of support I have been privileged to receive over the past 5+ years. May God bless each and every one of you and may Bethany continue to be a beacon of light and hope in a world desperately in need of light and hope in the months and years to come.

Board of Managers Report

2021 was an anticlimax compared to 2020; the year that accomplished more than expected.

Three Options 1 projects were completed in 2021:

- 1. The new oil tank has been installed and came in under budget.
- 2. The steeple was removed with the exception of the original plinth.
- 3. The Sanctuary ramp was replaced. A grant from the province of Nova Scotia provided financial support in the amount of \$5500.

Fourteen projects remain. These include windows, exterior doors, siding, Sanctuary stained-glass repair, flooring, exterior brick repair and the drainage system on the flat roof over the boardroom/nursery/ladies parlour. The "big" Options 1 item will become a reality in three to four years – the Sanctuary roof.

Maintenance - Along with the usual parade of service providers, a large interior maintenance project concluded in 2021. The floor in the chair storage room off the Fellowship Hall. Starting in late 2020 the "chair room" proved to be another soft wall. The kitchen wall adjacent to the dish washer was removed (entire length and four feet high), the support wall below the dishwasher wall sill was removed and reconstruction began from the basement up. Once the basement supporting wall was completed, the kitchen wall was re constructed. Next the concrete floor in the closet was removed. The rotten joists were replaced, and the floor reconstructed in wood and finished in concrete. We were fortunate in that only one in floor heating pipe was damaged. With three trades involved the small chair room consumed a lot of time and money.

Parking Lot - It was the Board's intention to visit the condition of Bethany's parking lots. A plan was launched to repair, patch and line the two lots and develop a signage strategy. Estimates were sought but owing to financial concerns the projects were deferred to 2022. Coupled with parking lot maintenance, the signage plan would identify Bethany parking spaces

across from the back entrance in the large (rear) parking lot. These (three) would be free standing. Other post type signs would be located at the Clinton Street entrance and the walking path entrance near Lepperts brook.

Bethany's Kitchen - The Bethany Kitchen moved forward in stages. From kitchen planning in March to liquidation of specific kitchen furnishings, a motion to support canvassing the congregation for funds was passed (coupled with the Board of Trustees support). Renovation commenced shortly thereafter. Images were sent in the December's Community Spirit.

Gym Floor - The gym floor, not unlike the Kitchen, grew from congregant interest to a project in itself. The floor, as with many Bethany projects, offered more challenges than expected. The finished product is amazing complementing the volunteer painting, the gym never looked so good. Funding for this project came from two congregants' contributions. A grant from the City of Halifax is being sought to cover the balance.

Communication Strategy Options 1 - Betty Tozer was asked to provide a communication strategy offering an overview of Options 1. This large task is to produce a document(s) for Board of Managers review, presentation to the Executive Board and finally to the congregation. Since Options 1 is in its final stages; prioritizing remaining projects, accountability, and an historical record are all pertinent to one of Bethany's largest endeavors.

Last but not least are the volunteers who installed, repaired and painted through 2021. These tireless souls fixed and brightened a tired complex. By the way they cut grass too!

Treasurer's Report

(Part 1)

This report will be in two parts: the first one from myself, as treasurer until the end of October 2021 and the second one from Rob Steeves who assumed the role of treasurer on the 1^{st} of November.

Our hope of having life "back to normal" by the end of 2021 was dashed by the arrival of the Omicron variant of Covid. Just when our congregation was beginning to return to more normal conditions in the sanctuary and our thoughts were turning to social gatherings, fund raising events etc. we were put back in lockdown mode once more.

Unfortunately, this has meant that our finances have not bounced back as much as we had hoped this year. We did receive a wage subsidy grant from the government to help defray costs in that area. We were also able to access the loans that were made available from the federal government in the amount of \$60,000. Only \$40,000 of this needs to be repaid, if it is done by the end of 2022, meaning that the other \$20,000 becomes a grant. This has been very helpful in keeping us going in 2021.

I urge you to keep Bethany in your thoughts when planning your donations for the coming year.

It has been my privilege to serve as your treasurer for the past 3 1/2 years.

(Part 2)

I took over as treasurer November 1 and, after two weeks, briefly wondered what I had gotten myself into. We had just cautiously begun to reopen to in-person services in the fall when Omicron became part of daily conversation. By Christmas Eve, Bethany would be back to virtual services only. When I came on board, Linda had expressed her concerns to me that financially we could have trouble "balancing the books", in spite of the wage subsidy and another grant from the United Church that we received for work done to the premises in 2020.

I poured over the books.....started looking at trends...using spreadsheets to do projections...(I love spreadsheets!)....and said lots of prayers. The people of Bethany came through as you always do!! I'm happy to report we will close the books on 2021 with a modest surplus. However, that surplus does come with an asterisk beside it, as, if it hadn't been for the wage subsidy and the grant from 2020 arriving in 2021, I would be reporting a deficit.

That said, a lot was still accomplished in 2021. Option 1 work continued, our newly renovated kitchen is almost ready to be unveiled, and the floor in the gym has never looked better, all thanks to the generosity of dedicated Bethany congregants.

As I look forward to 2022 and beyond, I sense challenging financial times. There is still Option 1 work left to be done. We will soon be reporting to you on where we stand with that important project. There are other infrastructure and maintenance items not included in Option 1 that need to be considered and prioritized. Costs of everyday items are on the rise, most notably fuel oil and electricity.

I'm not one to make predictions barely three months on the job, but I am confident that Bethany folk will rise to whatever challenge we face. I want to close by thanking Linda for her tireless work during her tenure as treasurer. I also want to thank Tina Gascon for her ongoing efforts to keep all financial records up to date, our bills paid, and keeping me up to date on the various reporting requirements we must fulfill. It is because of their hard work that we are in as good shape financially as we are.

Lastly, I want to thank each of you for your continued support of our community of faith!

The Janet & Earl Reid Scholarship Fund (the Fund)

THE EARLE AND JANET REID SCHOLARSHIP FUND ("the Fund")

Under the provisions of his Last Will and Testament, Dr. Earle Reid generously donated to Bethany United Church the sum of \$100,000.00 to fund the Earle and Janet Reid Scholarship Fund ("the Fund"). Under the provisions of his Will, Dr. Reid provided that the net annual income of the Fund be distributed annually by Bethany by awarding two annual scholarships to recipients attending a secondary or post-secondary educational institution who are active participants in church activities.

The funds were transferred to the Community Foundation of Nova Scotia to invest on Bethany's behalf. CFNS is a public charitable foundation established by Nova Scotians for Nova Scotians which works with private donors to build the financial and social capital of our community by establishing permanent endowment funds and providing the expertise to maximize the benefit to each of these funds. Since all the funds of the CFNS are pooled and invested together, the CFNS is able to keep investment costs low in order to maximize the benefit of each endowment fund. The monies in the Fund are invested in a balanced fund comprised of 60% equities and 40% fixed income. The CFNS charges an annual management fee of 1.77% for each fund and provides annual and quarterly reports.

Under the terms of Bethany's agreement with the CFNS, an Adjudication Committee consisting of three members of the congregation and a representative of the CFNS has been established to review all applications for the two annual scholarships and to recommend the two annual recipients of the scholarships as set out in Dr. Reid's Will and then to forward their recommendations to the CFNS's Board of Directors for final approval. In 2020, the two members from Bethany who sat on the Adjudication Committee were Nancy Dearn and Greg McConnell. The CFNS is responsible for promoting the Fund.

This past year (2021), the two annual scholarship awards were granted in the amount of \$2000 each to Kyla Mills and Thomas Duck, both of Bethany United Church.

Board of Trustees Report

The role of the Board of Trustees is to hold all real property occupied by the Congregation of Bethany United Church in trust for the United Church of Canada and to ensure that all the congregational property is used for a purpose not contrary to the provision of the Trusts of Model Deed.

In the midst of the pandemic, in 2021 the Board met on April 22 and June 8 to discuss a number of matters requiring the Board's attention.

In our April 22, 2021, meeting, the Board discussed the following matters:

- 1. A proposal by a representative of RBC Wealth management to convert Bethany's investment portfolio (ranging between \$400,000 and \$600,000) to a managed account for a 1.4 % annual management fee;
- 2. To consider a request from the Board of managers to access funds from Bethany's investment portfolio to fund the proposed kitchen renovations.;
- 3. To proceed with an inventory and appraisal of Bethany's personal property for insurance and replacement value purposes;
- 4. To review a previous decision to produce a draft "handbook" setting out the different responsibilities between the Board of managers and the Board of Trustees.

In our June 8, 2021 meeting, the Board discussed the following matters:

- 1. Authorizing the Chair to contact HRM to discuss the proposed changes to the land use bylaws that might impact Bethany United Church;
- 2. After hearing a presentation from Kim Reardon, a member of Bethany, and representative of CIBC Wood Gundy, the Board decided to convert Bethany's investment portfolio to a managed account for a period of one year for an annual management fee of 0.5% on equities; 0.25% on fixed income; no fees on cash;
- 3. Authorizing the sum of \$100,000 to remain in cash in Bethany's portfolio for use by the Board of managers to pay for the cost of renovating the church kitchen;
- 4. Approval of the renewal of the Toshiba photocopier for the church office;

5. Confirmation that all contracts involving Bethany United Church need to be approved and signed by the Board of Trustees.

LOCAL OUTREACH MINISTRY

Jesus said, "For I was hungry and you gave me something to eat, I was thirsty and you gave me something to drink, I was a stranger and you invited me in. I needed clothes and you clothed me. (Matthew 25:35-36)

Local Outreach is a ministry of session and is directly supported by the congregation through designated contributions in the weekly offering envelopes. On behalf of Bethany Church, this money is used to serve persons in need of food and clothing items in the Metro area. A list of community agencies supported during the past year may be found in the Committee's financial report.



This past year proved to be challenging for so many people, especially those in need of food and shelter. The volunteers at St. Andrew's Sunday Suppers continue to go above and beyond, making certain every person who arrives for a hot meal on Sunday receives one. With the continued support of local churches and organizations the supper team also provides personal hygiene items, warm winter clothing, tents, and snack foods. Bethany has continued to be very generous with their support to this growing need. We provided casseroles in January and November as well as sandwiches a few times throughout the year. We are no longer able to offer our usual meal of ham and scalloped

potatoes as the meals continue to be take-out only. During the pandemic, numbers attending the suppers continue to increase, many Sundays they have served more than 300 guests. Many thanks to Bethany for also providing fresh fruit donations for the suppers.

Since the pandemic began we have not been able to serve breakfast at the Brunswick Street Mission in the wee hours of the morning, as we had done two or three times a year in the past. The Mission continues to serve breakfast and provide other outreach services with a select team of volunteers and staff. We would like to thank all those Bethany folk who supported the Mission's Annual Fundraiser Breakfast in October, whether you attended in person or virtually, your support is greatly appreciated.

During the late fall, the Committee sponsored a number of projects to support programs during the Christmas season. Through our clothing box, the Brunswick Street Mission, Phoenix Programs for Youth, Fairview Family Resource Centre and other agencies, received many articles of warm clothing. Special thanks to those of you who take the time to knit warm hats, mittens, and scarves, your time and care is greatly appreciated. Many of you generously donated non-perishable food items and funds to the Halifax West Ecumenical Food Bank to provide meals and Christmas dinners. We also continue to collect feminine hygiene products as well. More than 100 gifts were donated to the Angel Tree and were forwarded to the Salvation Army for distribution. Each year the Bethany Youth Group hosts An Old-Fashioned Christmas in support of Phoenix Youth. The support for this outreach initiative has been incredible during these past two years and the folks at Phoenix are truly grateful. Many Christmas stockings have been filled thanks to your support!

The committee wishes to thank the congregation for their warm and generous support, both financially and in other ways over the past year. I would like to thank the committee members for their dedication and efforts in the work that they do to serve others in our community. Thanks also to Dana Mills and Tina Gascon for their administrative assistance and support and as well to Louisa Duck, the Bethany Sunday School, and the Bethany Youth Group for their continued support of Bethany's Local Outreach projects. It is greatly appreciated and a wonderful way to involve the youth of our community.

Children and Family Care Ministries

It continues to be my great privilege to serve the congregation as the coordinator of our Children and Family Care Ministries. 2021 gave us an opportunity to continue exploring new ways to offer programming, and we moved Sunday School to the Zoom platform in February. We met virtually on Sunday mornings and continued our faith journey together until the end of May. We continued to send out lesson and activity packages to all our families so that they could continue to participate on their own, if they preferred. Owing to continued Covid restrictions, our JAM program and Vacation Bible School were suspended for the year.

Our summer was busy! I was happy to have the opportunity to preside over the four Sunday services in July. I appreciate all the help and support offered by my colleagues, and the great encouragement I received from the congregation. Thank you.

The rest of the summer was spent, with the help of Elizabeth Carter, reorganizing and revamping the Sunday School space and program to make it Covid-safe so that we could come back in person with the children as soon as government restrictions allowed. With the support of the congregation, we purchased a folding room divider that allows us to turn the gym into two classroom spaces that can hold two socially distanced classrooms of twelve students each. We were thrilled to try out our new Sunday School space in late September, when we welcomed our children back in-person. The children were registered each week by their adults and entered through the ramp door on the Joseph Howe Drive side of the church, separate from the congregation, and came directly to the gym. This was the safest course at the time since the children were not yet able to be vaccinated. We had a small but steady number that attended regularly until Christmas, when we had to return to online Sunday School because of rising numbers. We are set to return to in-person as soon as it is safe to do so.

We had five candidates for confirmation complete their preparation this year and join the church in October. We welcomed Jared Dearn, Kelsey Matheson, Nathan Mills, Heidi Reardon, and Vivian Richardson as full members of the church, and we look forward to their continued participation in the life of Bethany.

Our Prayer Shawl Ministry was able to start distributing shawls again in 2021, and we shared eighteen shawls with Bethany family and friends. We had six high school graduates in 2021 for whom shawls were created. We congratulate Ben Cameron, Katie Duggan, Laura Duggan, Thomas Hooper, Sam MacFarlane, and Kyla Mills, on their achievements. We also held a prayer shawl blessing during a Sunday Service in July, in which thirty-eight shawls were blessed. Our crafters were very busy over the last year, and we thank them for sharing their gifts of time and talent with others.

We were happy to be able to hold our traditional Olde-Fashioned Christmas event in support of Phoenix House this year in person. We held the entire event outdoors, beginning with The Living Nativity, and then carrying on with carols, crafts, and cookies, and a visit from Santa. Dan Isner once again kindly brought Rosie the donkey and the goats out to join the festivities and everyone had a grand time. Dan also supported our Christmas Eve family service again this year by bringing Rosie along, though we recorded the Nativity portion of the service in November as a contingency plan. We were glad to have that ready as it became clear that an online service would be the safest way forward this year. With the great help of John Briand and Barry Paton, all parts of the service were recorded and edited together and offered as our family service on Christmas Eve.

I thank you all for your support and encouragement as I continue to serve the congregation of Bethany. I am truly blessed to be in this role, and I look forward to whatever adventures and opportunities the next year brings.

Community Engagement Ministry

2021 has felt much like a rollercoaster ride, with ups and downs experienced through lockdowns and re-openings. The Bethany community has proven to be very resilient! Through all the challenges we have faced during this pandemic we continue to find creative and safe ways to be in community with each other, whether in-person, virtually, through emails and telephone calls. No matter how we find community, it continues to be a privilege to minister with each of you in my role as Community Engagement facilitator.

The Bethany Youth Group began the year virtually on Zoom. This was not where we had hoped to be but nonetheless we were happy to see one another's smiling faces without masks! In February we could be in person once again and enjoyed a skate on Chocolate Lake. In March we made snacks for St. Andrew's supper and in April Louisa taught us how to knit, we also had our annual Earth Day hike and trash collection. Unfortunately this was our last in person gathering as we encountered another lockdown. So, back to Zoom, where we baked cookies together, shared our favourite music, and played Trivia with Shawn and Kevin. We wrapped it up with an online Escape Room Game the end of May. In September we were able to gather in person (with masks) and thankfully this continued until our Christmas Break. Some highlights of the fall; a hike with Christie Chisholm at Fox Lake Trail; snack making and winter clothing donations for St. Andrew's Sunday Suppers; Blessing of the Animals with Kevin; and our treasured Living Nativity and Old Fashioned Christmas, which was held outdoors this year and as always included a visit from Santa. Bud MacDonald had been our beloved Santa for a number of years, with Bud's passing his son Michael offered to play this role. We are very grateful, it was truly a special evening. As always the Bethany congregation generously donated stocking stuffers for the youth at Phoenix House. Special thanks to Dana Mills for her continued support as a volunteer youth leader.

Youth Confirmation class was held on a Friday in April. Louisa and I met with 5 youth confirmands in the Chapel for our first session of Narthex, a confirmation curriculum developed by Maritime Conference. It was a great day of learning and engaging conversation. Unfortunately our next session was postponed due to another lockdown, as was our Confirmation date of May 16th. Louisa and I met with the 5 Confirmands for part two of our Confirmation sessions in October. Confirmation took place on Sunday October 24th during morning worship.

Zoom Virtual Coffee Hour was a new initiative hosted by Kevin and myself on Monday mornings for an hour which ran from February to early May. Since we could not gather for our usual Sunday morning coffee hour this virtual platform offered a safe place for Bethany folk to gather for friendly conversation. We had a consistent group of people who enjoyed seeing one another each week to share stories and enjoy one another's company.

The Walk and Talk/Drop- In program was able to resume mid –February until the next lockdown in April. This program offers a place where folks can walk indoors if they choose, enjoy music by jazz pianist Murray Brown. Each week ended with a "physically distanced" conversation circle led by Kevin and myself. In November we were able to gather in person once again for indoor walking, music with Murray Brown, percussionist Huntley Blair and violinist Susan Zurowski. This jazz trio turned out to be the highlight of our week as it brought us great joy to hear live music once again! Kevin joins us once a month for engaging conversation. This program in pre-covid times offered tea, coffee and other social activities, which we hope we can offer again when it is safe to do so.

Guided Meditation led by Yvonne Macor, took place in person in the MacKinnon Chapel mid-February until mid-April when we moved to online until early June. We met again in October to early December in the Chapel. These sessions were well attended by Bethany folk and the surrounding community. We are very grateful to Yvonne for continuing to volunteer her time and talent as we form community meditating together.

Picnic and Prayer was a program offered for three Tuesdays in September. We met at the Dingle and also Horseshoe Island. Folks brought their lunch and a lawn chair. We began with a social time (physically distanced) and then while folks ate their lunch I shared a scripture reading and Kevin offered a short reflection. Outdoor ministries are a safe way to bring folks together safely in Pandemic times as long as the weather cooperates, our third gathering was cancelled due to rain!

Music Mondays Soiree! For three Monday evenings in November Shawn and I offered a 45 minute concert featuring a musical mystery guest each week. The mystery guest was introduced at the beginning of the evening with trivia questions for the audience pertaining to the musical instrument this guest played. Our three guests were Curtis Dietz –Trumpet; Hilary Brown –Cello; and Debbie Miles –Violin/Fiddle. There were approximately 80 people in attendance for each concert. We had a delightful time performing and the audience greatly appreciated the music as well as an evening out with other Bethany folk; so much so that we have been asked to offer another series in the spring. Stay tuned!

The Congregational Care Team of Bethany consists of volunteer lay persons offering care and support to our congregation. This ministry supplements the visitation ministry of our lead Minister. During the pandemic when in person visits and Sunday morning worship were no longer permissible, a congregational phone tree list was resurrected and members of the care team and others, made weekly phone calls to Bethany's congregation. This proved to be an important and much needed ministry and continues to be so especially in times of lockdowns and visiting restrictions by Public Health. Thank you to all who make these much appreciated calls. The care team volunteers delivered the UCW Christmas Gift Bags to parishioners in December. A much appreciated gesture.

Due to pandemic restrictions and kitchen renovations we are missing our Joy Lunch, Community Meals, ISANS Conversation Circle and other programs that have not been able to happen. We hope that in 2022 we can offer these programs, perhaps with a twist, to meet Public Health Guidelines. As staff liason to the Community Connections Working Group we have not been able to offer new initiatives at this time but we hope to offer take-out meals when the kitchen renovations are complete.

I would like to express my thanks to the Audio/Visual team for their amazing efforts to record and live stream our worship services, and to the staff as well as Board and Session members for their dedicated efforts during these challenging times. It is truly a blessing to be a part of such a caring congregation where a strong sense of community, connection, and a deep faith are unwavering even in pandemic times. We are not alone. Thanks be to God.

Ministry of Music



It is through challenging times that one must be most creative, adaptive, and willing to change with but a moment's notice. The idea of 'taking things for granted' is no longer, and the notion of 'but we have always done it this way' is not an option, at least for the present. In my role as your Director of Music, I work with a variety of people, both staff and volunteers, whom which the above is not only true, but the new normal by which we must currently abide. Having said all of that, it has truly been a dynamic year of Music Ministries at Bethany in both some tried and true ways, and in some brand-new approaches.

The Senior Choir this past year has been a series of 'musical chairs' if you like. We were put on hold and not allowed to rehearse for public health protocols, and then we were allowed to rehearse according to updated protocols. We met in the Fellowship Hall and rehearsed according to NSHA guidelines. We participated in weekly services singing mostly from the balcony so that we could socially distance. Then we were allowed to move back to the choir lofts down front which was a great plus for the choir and the congregation both visually and listening-wise. However, during December the choir had to return to the balcony for one more time which coincided with our Annual Service of Lessons and Carols. After which, the church went into a lockdown just intime for Christmas Eve, and with no choir or congregation. So, it was a year with much singing but also changing conditions with regards to modes of participation. Thank you, choir, for being such an accommodating group and with such a 'go with the flow' attitude.

The Handbell Choir also faced many of the same challenges as the Senior Choir but was also willing to meet change with an open-mindedness and just to remain positive. This choir rehearsed regularly in the Sanctuary, socially distanced, and with masks. They were able to play in church nearly as much as other years so that was wonderful. A highlight for the Handbell Choir was their participation in the Annual RCCO Carol Service which took place in late November at All Saints' Cathedral. We joined with the St. Matthew's Choir, and we all performed for a large congregation, and it was so rewarding to be a part of this event.

This past summer I started a 'Summer Sings Choir' which met on Tuesday mornings for a 45-minute session of group singing. This was a very successful endeavour and we averaged about 14 people each week. This choir would provide hymn singing and ministries of music for the recorded services during the summer months. This proved to be such a viable resource for all involved that I may just repeat for this coming summer.

As an example of adapting to the everchanging pandemic landscape with regards to what we were allowed to do and not do, I, in response, offered a music lecture series this past spring entitled 'Sacred Music through the Ages.' This was a weekly series that traced church music from the beginnings, Gregorian Chant, up to and including the 20th and 21st centuries. This was well attended and brought together a collection of people from outside of the regular folk that I tend to directly interact with, that is, choir members.

If someone would have said to me even a year ago that I would be teaching a beginner Ukulele class at Bethany to a group of 17 people, well, I think that we know what the response would have been. So, for seven consecutive Wednesday evenings, we faithfully met and learned the basics of playing the ukulele including chords, strumming, plucking, and even a few songs.

Another venture that proved to be very successful this past November was the Music Monday soirees which included along with Ann Bradley and myself, a mystery music guest. This mystery music guest was unknown until the very start of each concert and then was introduced and performed a 45-minute program with us. The three music guests that took part in the series were: Curtis Dietz, trumpet, Hillary Brown, cello, and Debbie Miles, violin/fiddle. These 3 concerts, despite horrific rainstorms during two of

the shows were well attended and raised over \$900.00 for the Paul Rackham Memorial Music Fund. Thank you to all that came out to support these 3 shows.

One of the events that I was so happy to have happened this past year was my favourite, the Silent Movie Performance. This year I was able to perform again The Phantom of the Opera. This screening was very well attended by over 160 people. My very special thanks to Ann Bradley who provided the singing for the character 'Christine,' and to Barry Paton, my formidable IT person and screen technician. This event raised just over \$1600.00 which was donated to the general operating budget. Hopefully, I will see you next year as I will soon be planning my next silent movie to be screened in October 2022.

Rev. Kevin asked if Ann and I would provide musical offerings for his December faith study entitled 'Do You Hear What I Hear.' For 4 consecutive evenings in December Ann and I, following Kevin's introductory remarks, would assimilate a short 15-minute performance to go along with his commendatory. This was a first for me, offering music to enhance a faith-study and it was a very worthwhile endeavour.

In closing, and as I reflect on the activities of the past year, we were able to accomplish a great deal considering all the obstacles that had to be overcome. This does not happen individually but with a great community of people such as Bethany United. I would like to thank the endless support of the staff that I am surrounded by, the many volunteers, and the various boards of Bethany that makes much of the above possible. I do look forward to the new year and the possibilities that await us through pandemic times. Limitations breed creativity, and I for certain am ready to continue to look for new and unique ways to carry on with the music ministry program at Bethany United.

Audio Visual (AV) Ministry

Technology has played a key role in our community of faith's ability to stay connected during the pandemic.

This couldn't have happened without important contributions of time and talent from three groups, each of whom had individually been providing technological support to the congregation even before the pandemic. These groups included

- the AV committee, whose primary focus was audio in the sanctuary.
- the Vision ministry, primarily focused on the fellowship hall and Visuals, and
- IT/Web support, whose traditional focus has been computer/internet/web support.

As a result of these three disciplines joining forces, we've been able to stay in touch through numerous virtual means, including a mix of pre-recorded and livestream services, ZOOM coffee hours, Communion services, faith studies, weekly meditation sessions, youth group and Sunday School. We've also leveraged these platforms to allow the various boards and committees as well as Session to continue to meet on a regular basis.

Late in 2021 we realized the synergy of bringing these technologies together would allow us to further leverage these media to the benefit of the collective wellbeing of Bethany. As a result, in late November the AV Ministry was created/approved by Session.

The full scope of the AV Ministry is being fleshed out, but will encompass, at the very least, the livestreaming capabilities, prerecording capabilities, ZOOM capabilities, and various pieces that go together to provide those tools. It also means we will be looking at ways each of these capabilities can be further leveraged going forward to further enhance and complement existing activities.

For this Annual report, there will still be separate reports from each group. Next year there will only be a consolidated report of the contributions of the newly declared "AV Ministry" to our community:

1) Audio Visual Report (Sanctuary)

2021 was the most exciting and challenging Audio Visual (A/V) year in producing and recording Bethany Sunday Services.

Born of Barry Paton's willingness to start a recording process and coupled with Shawn Whynot's encouragement to investigate Switcher Studio software resulted in a digital journey using iPhones as cameras, and an iPad to record the blended audio and visual elements.

Recording is one aspect of the experience but the real breakthrough in Sunday Service was live streaming.

This Ministry did not happen with the "flick" of a switch. Many long hours of reading manuals (thanks Bill), learning new equipment, experimenting and experiencing a "brave new world". Yes we had our ups and downs!

Now we have a borrowed digital audio console, an iPad blending audio and video signals, and three iPhones serving as cameras mounted on digital tripods. The latter offers horizontal and vertical movement so the iPad operator can choose camera angles.

All of the above serves up to 300 viewers (when Church is not in person) and approximately half that when we distance in person.

There were other aspects of this technology...the cost.

In 2021 \$5815 of donated funds was spent on audio equipment, software licensing, iPhones, Digital Tripods (Osmos), and related cables etc...

Donations were from congregants and the Rackham Music Fund.

The closing financial balance as of December 31 2021 was \$0.00.

Any Ministry needs help – human help. The A/V team welcomes Steve Morley and Penny Allen to the Sunday morning experience.

A large vote of thanks goes to the following volunteers: Barry Paton, Rob Steeves, Bill Roger, Steve Morley, Penny Allen and Glen Knapp.

2) Vision Ministry (Fellowship Hall)

The purpose of the Vision Ministry is to enhance the Word or Music through the use of visual images and/or videos where appropriate.

Since the arrival of Covid in 2020 and the church renovations, the stage in the Fellowship Hall was not available. It was used as a storage area and will not be available until the kitchen renovations are complete (soon).

During 2020 and parts of 2021 the vision team recorded and produced the weekly prerecorded services. In January of 2021, the extended Vision Team started building a streaming system for use in the Sanctuary. Some of the Hall's equipment including the QSC audio mixer was loaned to the Streaming Effort.

Now that the stage will soon be available, we begin the long-awaited renovation in the Fellowship Hall. A new screen will be purchased and installed. It is a hidden screen which can be lowered to a variety of heights so that the projector system can be used for large functions and small functions. Usage will include funeral receptions, plays, concerts, Men's Club, Joy Club etc. It will be fully integrated with the sound system. We believe this will make the Fellowship Hall a prime space for external rentals.

And although regular meetings did not happen, we were still able to make a very kind donation to one of our congregation members who required some assistance at Christmas time.
