# Message from the Minister

For we are God's servants, working together; you are God's field, God's building 1 Corinthians 3:9

Jesus teaches us about a unique "Kingdom", some might call it a kin-dom, not building. Let that assertion sink in for a spell. Throughout the Gospels, you can find Jesus teaching on the characteristics of this "Kingdom" where kin or family are defined as being part of something larger than yourself and connected to people who may not necessarily share our history, ethnicity or experience. But together there is an appetite, a hunger, to embrace the character of God in the world that makes us different people. The Church was never about brick and mortar. It was always greater than that. It was about a way of being in the world.

People are the building blocks. Jesus feeds the 5,000. A crowd has been listening to Jesus teach on a remote hillside, you might call it a two-thousand-year-old version of a TED-talk. The gathering there is a mix of the invested, the curious and the skeptical. No sanctuary or liturgy; only Jesus speaking about God in real-time and then sharing a meal with those gathered on the hillside. That would be the model throughout the New Testament: Gather. Eat. Share. Remember me. Live.

The Church grows without a building campaign. The early believers were essentially in-house churches where immediate family, extended family and friends were already living in deep, meaningful community together. They didn't have to rent out space and a sound system and start service planning. They were already living life together organically and so they didn't need to create a destination to foster community. These groups absorbed the new converts, but there is no evidence of the healthy evolution of these communities into organized churches. The only mention we have is in the book of Revelation where large, opulent churches are being chastised for their corruption and apathy.

Jesus says where two or three are gathered he is present. Two or three—not 40 or 150 or 6,000. Not an auditorium with a speaker, a band and dozens of rows of chairs. This is Emmanuel "God with us." Jesus never promises that with size or organization there would be more of his presence. He didn't leave building instructions or establish an organizational structure or provide liturgical templates. He affirmed that his people and his presence were the only necessary ingredients. They would come to the table together, and he would take a seat there with them. Your kitchen table, a bar in a tap-room, a bench at the park, a coffee shop. He is present there.

The Apostle Paul tells us we are the Temple. In his letter to the Corinthians, Paul writes to tell Christians in that city that God's presence is not just above and around them but within them. They are the very "Body of Christ" on earth, they are the "temple of the Holy Spirit"—living, breathing sanctuaries. The idea of them needing to visit a specific place to have proximity to God was now ludicrous. They were the

place. They needed only to go inward. This is the heart of the Church then. It still is; not where they gather, but as they gather.

Jesus tells the disciples to remember him. At their final meal before his death, Jesus offers bread and wine as a symbol of his presence in community and sacrificial love. He then asks them to remember him when they break bread together in the future.

You may find that building comforting or edifying, and you may find inspiration and wisdom there. That may be spiritual community for you. But don't assume that this building has the market cornered on any of those things, and don't cheapen the spiritual journey of those outside of the building by acting as if everything found there cannot also be found beyond it. Over and over the Bible makes this clear.

All of this Biblical and ecclesiastical introduction is my way of talking about the kind of faith community Bethany was in 2017. Inside and outside our building there was evidence of a "kin-dom" alive in the midst of the world. People who were challenged by life found our community warm and inviting. People who were grieving found our church alive with care and support. People who were hungry for something new found ministries, new and old, to invest in, participate in, and thrive in. People who felt isolated, alone or just separated from their deeper selves found our community a place to call home. What a blessing!

I want to thank all of those who took leadership to express what God is doing among us. Thank you! Your offering, your insight, your work, made a significant difference to many people. Our congregation grew in numbers, our revenues increased (despite losing many, many generous donors in 2017) and our activities grew in number and in the numbers of those who participated. The one challenge we faced as 2017 began and as 2017 ended was our physical plant, which continues to occupy much of our attention and resources. If not for expenses related to the building we would have had a sizable surplus to spend on our mission and ministry. We will need to keep that reality in our minds and hearts as we move forward as a church community, living out the "Kingdom of God" in our midst.

Shawn Whynot has been our Director of Music for 20 years. He tells me the choir, with 33 members now, has never been bigger in his tenure. The choir shows us the way, their care for one another is a beacon to us all on how to care for each other, have fun with each other and share our God-given gifts with others. Whether they are in their usual "stall" or at 5 Ramsgate or singing at a senior's home, the location matters less than the spirit they carry.

Thanks be to God for the spirit that we carried in 2017.

# MINUTES 2016 ANNUAL CONGREGATIONAL MEETING BETHANY UNITED CHURCH MARCH 26, 2017

David Rackham advised that there was no correspondence to be addressed at the ACM.

Carl Webb moved that the Agenda be approved as circulated. Motion seconded by Maureen Reynolds. Motion carried.

Don MacKay moved that adherents of Bethany United Church be enabled to participate in the survey process. Motion seconded by Charles Maxner. Motion carried.

David Rackham gave a brief explanation of the survey process. Once the overall results have been analyzed, they will be shared with the congregation.

David then instructed the congregation on how the survey form should be completed. Members were asked to print and sign their name to receive a survey form. Once they completed the survey and deposited the completed form in the ballot box, they were be free to leave.

# Bethany United Church Executive Board Annual Report 2017

The Executive Board (EB) is generally responsible for exercising overall leadership in the care and oversight of the spiritual life, activities and the work of the Congregation, the care and maintenance of the church property, and to act as a liaison between the Congregation and Halifax Presbytery. In receiving and disseminating reports from the various boards and committees that comprise the governance framework (polity) of Bethany United Church, the EB also serves the important function of keeping people informed of the ongoing activities, opportunities and challenges faced by the Bethany community as it seeks to be an instrument of God's kingdom here on Earth. EB meetings are the only real forum where a sharing of the activities of the various boards and committees of the church occurs on a regular basis. You are referred to the reports of these individual boards and committees for details. Normally the EB would meet five times during a given calendar year while a small informal Sub-Committee of the Executive Board meets on a more frequent basis as necessary to keep abreast of ongoing developments at Bethany and to prepare for the next regularly scheduled meeting of the full Executive Board. I express my deep appreciation to all members of the EB and the Bethany community at large for their encouragement and support throughout 2017.

During 2017 the EB met on eleven (11) occasions including the Annual General Meeting (AGM) and a special congregational meeting for the congregation to render its verdict on options for the future of the Bethany facility. The highlights of these meetings are outlined below:

- January 4<sup>th</sup> 2017. After the departure of visitors from Halifax Presbytery, a matter related to office management was considered along with a report from the Facilities Planning Committee (FPC) on options for the future of the Bethany facility and how to share this information with the congregation at large.
- January 16<sup>th</sup> 2017. The main item of business addressed at this meeting was a proposal by Rev. Kevin Little that given the departure of Rev. Dr. Randy Crozsman as Minister of Visitation and Pastoral Care, Bethany might consider embarking on a one-year experimental period with Rev. Little taking care of his usual duties as Lead Minister along with many of the duties associated with the position of Minister of Visitation. After considerable discussion, this one-year experimental period was approved by the EB subject to re-examination at the end of the trial year. The Minister of Visitation and Pastoral Care position remains on the books, and should circumstances warrant, that position could be filled again in the future. A report by the treasurer on a proposed longer-term reorganization of the front office was presented and after extensive discussion was approved by Board members for implementation. It was also reported at this meeting that a long-simmering disagreement between Bethany and Halifax Presbytery in respect to arrears in annual payments by Bethany to Presbytery had been resolved.
- January 23<sup>rd</sup> 2017. This special meeting of the Executive Board was held to receive a presentation by Betty Tozer of the Facilities Planning Committee (FPC) on the various scenarios (options) that this committee had developed for the future

- of the Bethany facility. The options presented in brief were: (1) maintain the status quo, (2) partial development, (3a) removal of a portion of the facility and replace it with a new building, (3b) removal of a portion of the facility and add parking, and (4) sell and move to a new location. It was decided to form a small committee to plan various ways of disseminating relevant information to the congregation at large prior to a special congregational meeting at which members of the congregation would be asked to render their opinion on the options outlined above.
- February 20<sup>th</sup> 2017. This EB meeting dealt with the following matters: (a) management of office administration in both the shorter and longer terms; (b) confirmation of time, date and agenda for the 2017 Annual General meeting (AGM); (c) scheduling a date and time for congregational voting on options related to the future of the Bethany facility and determination of a process for assessing the opinion of the congregation on these options.
- March 26<sup>th</sup> 2017. The 2017 AGM chaired by the Executive Board was held following Sunday Service. Minutes of this meeting will be available in the 2017 Annual Report for the church at large to be made available prior to and at the AGM 2018.
- April 10<sup>th</sup> 2017. This EB meeting approved a survey method for the April 23<sup>rd</sup> 2017 special congregational meeting to assess the congregation's attitudes toward the various options proposed for consideration by the Facilities Planning Committee for the future of the Bethany facility. It was also agreed that the chair of the Executive Board would take responsibility for analyzing and reporting the results of the survey first to the full membership of the Executive Board and then to the congregation at large. Initial work on a process to prepare Requests for Proposals (RFPs) to be submitted to a number of professional firms was approved.
- April 23<sup>rd</sup> 2017. The EB held a special congregational meeting following the Sunday service for the specific purpose of conducting an assessment of the congregation's preferences for the various options proposed by the FPC for the future of the Bethany facility. Following an explanation on how to complete the survey instrument, voting was conducted with dispatch and the results were analyzed over the following weeks for ultimate dissemination first to the EB membership and then the congregation at large. Overall, the survey revealed that a plurality of members of the congregation participating in the survey (N=117) opted for remaining at the present location if at all possible (the status quo).
- May 17<sup>th</sup> 2017. This EB meeting was called to consider in detail four remits developed by the 42<sup>nd</sup> General Council held in 2015 regarding various aspects of the future shape and governance of the United Church of Canada (i.e., its polity). Pastoral charges such as Bethany were asked to vote on five remits, four by the end of June 2017 and the fifth by the end of February 2018. Joyce Wylie, a member of Halifax Presbytery, kindly agreed to attend this special meeting to "walk" the EB membership through the remits as follows: Remit 1 (Three Council Model), Remit 2 (Elimination of Transfer and Settlement), Remit 3 (Office of Vocation), Remit 4 (Funding a New Model) and Remit 6 (One Order of Ministry). Detailed information on these remits was circulated to the Executive Board membership prior to a vote being taken at the June meeting of the Board. For those interested in more detail regarding these remits, please consult the following United

- Church of Canada website (<a href="https://www.gc42.ca/remits">https://www.gc42.ca/remits</a>). The other main item of business at this meeting was a discussion of the results of the survey on the congregation's preferences for the future of the Bethany facility and plans to move forward in this regard.
- June 21st 2017. The main purpose of this EB meeting was to conduct a vote on Remits 1, 2, 3 and 4 described above. Members unanimously approved Remits 1, 2 and 3 but declined to approve Remit 4. Results of the Bethany EB voting were relayed promptly to Toronto. Nationwide, all four remits were approved. The EB approved the transfer of archival material held on site at Bethany to the Maritime Conference Archives in Sackville, New Brunswick. A great debt of gratitude is owed to Norman Graham who spent a tremendous amount of time sorting through all this archival material and who then agreed to transport these files personally to the Archives in Sackville. Also considered at this meeting was a plan for developing a template for a Request for Proposal (RFP) to be submitted to various professional firms regarding the Bethany facility and the preferences for the future of the facility as expressed in the results of the special congregational meeting held on April 23rd 2017. A great debt of gratitude is owed to Betty Tozer for her continuing leadership role regarding this critical matter for the future of Bethany.
- September 27th 2017. This EB meeting dealt primarily with the outcome over the summer of RFPs submitted to seven companies thought likely to have expertise regarding the assessment and future development of facilities such as we have at Bethany. Despite an extended deadline, none of the seven firms felt able to provide a proposal regarding the feasibility of the top two options preferred by the Bethany congregation for the future of its facility. Finally, when approached again, one firm agreed to provide quotes for the two options in question but no detailed plan. Given the high price of these quotes, the EB decided to ask the Board of Managers to form a committee of people with relevant expertise from among members of the congregation who would conduct a survey of the current state of the facility, collate this with existing evidence from previous analyses, and in due course present their findings first to the Executive Board and ultimately to the congregation for its perusal and deliberation on a future course of action in light of the estimated cost of maintaining the status quo (staying in the same location), the most preferred option by the congregation based on the April 23rd survey results.
- December 11<sup>th</sup> 2017. This was the last EB meeting of 2017. A review of the one-year experimental regime of having only one full-time minister on staff was conducted and it was decided to continue with this arrangement for the coming year along with an extension of hours for Ann Bradley to both enhance our outreach programme in general and in so doing provide supplemental support for Rev. Little. Beginning in early 2018, Ann will be extending her current efforts in the fields of congregational care and community engagement, respectively. The 2018 budget as presented by Treasurer Don MacKay was discussed and approved as presented. The chair asked members to examine the current status of their EB membership

- to determine if they are eligible and willing to continue to serve on the EB from AGM 2018. A fund-raising proposal for Camp Kidston was presented and approved by the membership. Members were also asked to consult material on Remit 6 (One Order of Ministry) to be circulated in early January with a vote to be taken at the February 5th 2018 EB meeting.
- Letters of Commendation. During the course of the year, letters of gratitude for exemplary service to the Bethany community were sent to Rev. Dr. Randy Crozsman, our former Minister of Visitation and Pastoral Care, Normal Graham for his tireless work with Bethany's archival records as noted above, Tania and Peter Freeman for their service as coordinators of the 2017 Fall Fair, Karen Hatcher for her constant and invaluable support to the Bethany community, especially in regard to the Fall Fair on this occasion, and Rev. Kevin Little for his exemplary service throughout 2017 as Bethany's Lead Minister. We are deeply grateful to each of the individuals named here and also to the many unnamed individuals who together make Bethany United Church the very special community that it is.

Special thanks to Co-Chair Glen Knapp for his hands-on approach and perseverance to everything from rentals, to heating and lighting issues, to operating our sound system and to serving as a liaison between the Board and our Custodian.

Special thanks to Phil Reardon for continuing to offer his constructive insights into the myriad of repair issues that constantly seem to be presenting themselves.

Special thanks to Don MacKay for continuing on as Treasurer.

Special thanks to Peter Freeman for filling the role of Board Secretary.

Thanks to all the Board of Managers members who assisted in our tasks and donated their time during the past year.

Three Members will be stepping down as of March, 2018. Mark King has completed a three-year term and has decided not to re-offer. Don MacKay has finished his role as our Interim Treasurer and does not wish to continue on the Board. Peter Freeman has completed the third year of his second consecutive term. On behalf of the Board of Managers, I would like to extend our thanks for their time of service.

Our Complex consists of several buildings joined together and continues to require ongoing maintenance and repairs. Over the past year, our Board has been focused on addressing these issues. We sometimes find ourselves in an awkward position with regard to just what repairs and modifications should be done, in what order and to what degree. This is mainly due to the uncertainty surrounding our buildings' future.

The Board has addressed the following issues during 2017:

- Heating system abatement + new tubes in boiler and several parts replaced on burner and boiler (which passed inspection by Provincial inspector)
- Roofing sheathing removed on W side of FH; boards fastened to trusses to provide ventilation before re-shingling
- Office exterior repaired rotted wood along corner + area above canopy; re-shingled N side of office roof
- Canopy on JH Dr. replaced decaying wooden posts with fibreglass ones (donated)
- Sanctuary doors sanded, stained, and refinished
- Painting framework surrounding Sanctuary doors + Gym below chair rail
- Parking lots asphalt patching done + some lines repainted
- Signage FH parking; rear parking lot entrance and alongside Sanctuary

- Narthex new cabinets installed (donated)
- Minister's Office window installed in door
- Refuse & recycling 2 new sets installed in FH and kitchen (donated by Bethany Foot Care); larger outside bins for increased capacity
- Sanctuary continue to monitor the cracks in the glulam arches
- Lighting continue to review all lighting areas with emphasis on conversion to LED's
- Photocopier Sharp model replaced by a new Toshiba which will yield substantial cost savings
- Rentals continuing to re-evaluate gathering better understanding of long term renters and apply current community rates to new users
- Website Canada Helps has been set up

We have had a very productive and busy 2017. I am sure that 2018 will be much the same as we attempt to deal with ongoing challenges.

#### **TREASURER'S REPORT 2017**

2017 was a very good year from a financial point of view and I want to thank all of our members and adherents who contributed to our financial health. Our contributions from envelopes (both regular and special), PAR, loose, Sunday School, on-line donations etc. are up 9% from 2016. A fantastic accomplishment!! As well our annual fundraising events (Spring Gala/Auction, Fall Fair and Spooky Movie Night) continue to raise significant dollars for the congregation. Also the fact our Lead Minister Kevin Little took over the visitation duties in February 2017 upon the departure of Reverend Crozsman reduced our salary costs 20% for the year. All of this allowed us to pay for a significant portion of the repairs to our heating system and the Ewen Moase Fellowship Hall out of general operating income. The actual final results are reported under "2 year financial comparison" in the following pages. Also if anyone wants to see the Notice to Reader 2017 financial statement as prepared by our chartered accounting firm AC Hunter Tellier Belgrave Adamson please note it will be available at the annual financial meeting or in the church office.

I want to encourage everyone to keep up your contributions to the life and work of the church in 2018. If you are a new or for that matter a long term member or adherent of Bethany but not contributing on a regular basis I would ask that you consider going on PAR or taking out regular envelopes. We continue to face financial challenges in 2018 as we look at more repairs and consider possible renovations to our facilities that will ensure its future viability.

I have been serving as your interim treasurer for a year and a half now. It has been my pleasure to serve Bethany United Church in this capacity. I am happy to announce that Linda Knechtel will be taking over the responsibility of treasurer with the annual meeting in March. She is well qualified and I know you will welcome her to this role and give her the same support I have received.







During the year we have continued to hold special worship services including; monthly Jazz Vespers Services, New Members Sunday, Lent Communion and Worship Service, Service of Darkness on Good Friday, Palm Sunday Jazz Service, Easter, World Wide Communion, Thanksgiving, Children's Sunday, Remembrance Day, Advent Services, Service of Lessons and Carols, Christmas Children's Pageant, and Christmas Eve Communion.

The following are some of the matters discussed at the meetings of the Worship Committee during 2017: -

# LOCAL OUTREACH MINISTRY

Jesus said, "For I was hungry and you gave me something to eat, I was thirsty and you gave me something to drink, I was a stranger and you invited me in. I needed clothes and you clothed me. (Matthew 25:35-36)

Local Outreach is a ministry of session and is directly supported by the congregation through designated contributions in the weekly offering envelopes. On behalf of Bethany Church, this money is used to serve persons in need of food and clothing items in the Metro area. A list of community agencies supported during the past year may be found in the Committee's financial report.

In January a Toonie for Tummies Sunday was sponsored by the Committee to help defray the rising costs of our twice-yearly support of St Andrew's Sunday Suppers. This past year we served our traditional meal of ham and scalloped potatoes in February and November. On average 150 people attend the supper, enjoying this hot meal and voice their appreciation of our continued ministry. The supper is a very rewarding experience and a time of community for those who participate in meal preparation and serving this most worthy outreach. Many thanks, to Bethany for providing fresh fruit for these suppers. Also, in April, the renowned Bethany Players donated all proceeds from their incredible performance of "Finn McCool" to Local Outreach. These funds are greatly appreciated and provide much needed assistance to the Sunday Suppers and agencies we support on a regular basis.

In April and October, a No Food - Food Bank Sunday was sponsored by the committee to assist the Halifax West Ecumenical Food Bank. These two Sundays raised \$5000 for the Food Bank. The Committee also donated funds to supply snacks to the Phoenix Drop - In Centre where many at risk youth gather each day. The Bethany Youth Groups also donated healthy snacks and fresh fruit to the Food for Phoenix program.

During the late fall, the Committee sponsored a number of projects to support programs during the Christmas season. Through the Clothing Box, Brunswick Street Mission, Phoenix Programs for Youth, and the Salvation Army received over 200 articles of warm clothing, and so many of you generously donated non-perishable food items and funds to the Halifax West Ecumenical Food

Bank to provide meals and Christmas dinners. In addition, over 110 gifts donated to the Angel Tree were forwarded to the Salvation Army for distribution.



#### **Revelation Committee Annual Report**

Over the past year, the Revelation Committee has continued phase two of our mandate, reaching out the broader community to explore the perceived needs of our demographic that Bethany might be able to help fill. We have reached out to Shawn Cleary our District 9 councillor, Lena Diab our MLA, ISANS our immigration services organization, other churches in our community, and schools in our community. This process is ongoing as we gather information to build our awareness about community needs. Several initiatives have been identified as viable for us both through our congregational workshop and through our community outreach.

Dating back to the days of the 20/20 Visioning Committee, an easy to read digital sign for the Joseph Howe side of the premises has been a priority for enabling a more active connection with the Armdale community. To that end we applied for an HRM community grant in the amount of \$15,000 which was the maximum amount for the grant program. We were successful in being awarded but we are still waiting to hear if it is for the full amount. The cost of the sign is considerably higher than the amount we will receive, but we will hopefully find ways through fund raising to accrue the full amount needed.

Last winter, Ann implemented the Walk and Talk program which has been enthusiastically received by many seniors. It takes place every Wednesday morning throughout the winter months and Kevin joins the group once a month for an engaging conversation/discussion circle. This winter the *Ready, Set, Move* program (facilitated by Jenn Manuel from HRM Community Health Team) is being offered as well, in conjunction with Walk and Talk. Thanks go to Ann for arranging this opportunity.

An ISANS program, a *Conversation Circle*, for new immigrants and refugees, is now being hosted at Bethany once a week. This Conversation Circle will run for 10 sessions. A group of 6 volunteers from the Revelation Committee are taking turns assisting the ISANS facilitator each week. If this program is successful it may be continued with more Conversation Circles in the future. Not only is this an important outreach into our broader community, it has the potential of bringing new people into our church. While we wish to extend our support to them, it is also true the immigration community has much to offer us. Thanks go to Ann and to Shelley MacKenzie for their communications with ISANS enabling our involvement.

A Bethany community meals programs is currently getting under way with our first meal planned for February 26<sup>th</sup>. The idea of the community meals is to share all aspects of a meal – the menu planning, the shopping, the preparation, the eating of delicious nutritious meals, and the cleaning up afterward – as a community family. Of course, not everyone needs to cook or clean. Many will wish just to enjoy eating with others, or to purchase food from our 'take away' option. This season we plan to hold two lunches and two suppers and see which is most popular. Next year we will pick a regular date and time. This is not meant to be a fund raiser, but the program will be self-supporting.

The Revelation Committee will continue to begin or expand programs over time depending on our volunteer base and our community engagement. The mandate of this committee is to develop community engagement at Bethany based on the ideas of congregation and on the needs identified in our Armdale community. The growth of our church is up to all of us, so it is important to go forward in ways and at a pace we can support and sustain through our Bethany volunteers. Over the years Bethany has built, and it continues to build, a solid reputation as a church in strong support of family and community. In our own way, we contribute much to the greater good, and we do so through our great sense of team work. Bravo Bethany!

# Sunday School and Spiritual Care

The Sunday School had a busy and successful 2017. The topics covered included the parables, the events of Holy Week, the

early church, Samuel the Prophet and the anointing of King Saul and King David, and then Advent, with a focus on angels as messengers of God. Our students were always enthusiastic. We have approximately 35 children, ranging in age from 3 to 14, and most weeks, we have about 20 in attendance. We have a preschool/primary class for our 3-5-year olds, two mixed grades 1-4 classes, and a senior class for grades 5-9, which is our largest, with 12 students present when all are in attendance. We are blessed to have a number of dedicated teachers, and we were fortunate to welcome a few new volunteers to the group in September. Our programme would not run without the time and talent of these individuals, and we are grateful to them for sharing their gifts of ministry with the children.

The Sunday School students led three services last year, with JAM students providing the music; Celebration Sunday in June, Children's Sunday in November, and the Christmas Eve Family Service. At the Celebration Sunday Service in June, Sophie and Madeline Whynot spoke about their trip to Guatemala with Habitat for Humanity. The Sunday School and congregation collected school supplies for the girls to take with them, and they told us about the school to which they were donated. We presented nine Grade 3 students with Bibles, and two prayer shawls to our high school graduates, Charlotte Moase and Drew Williams. The Sunday School picnic followed in the Fellowship Hall. The Children's Sunday Service, held in November, was planned much more directly by our senior class. As a service project, the Sunday School collected coats to share with those in need in Halifax. The youth also prepared hot chocolate mix and popcorn seasoning mix for sale, with proceeds donated to Brunswick Street Mission for the purchase of hats and mitts. The coats were taken to Phoenix Youth Shelter, Phoenix Children and Family Services, and Out of the Cold Shelter, all of whom were very appreciative. The Christmas Eve Family Service, held at 4 PM, was again very successful, with a full house and Rosie the Donkey, who carried Mary to Bethlehem. Charlotte Jackson and Jack Freeman were Mary and Joseph this year. The Living Nativity was held on December 15th, and was a great success. Once again, Dan Isner generously provided the animals for both services.

Vacation Bible School ran the week of July 10-14, and was very successful. We had sixteen children registered, including six from outside Bethany. We spent the week exploring the Holy Spirit, and the children had a good time. Charlotte Moase was my assistant, and was invaluable. We used the Fellowship Hall, gym, and chapel each day, and also went out into the community, on nature walks and to the park. Homemade cookies were provided each day by a number of different members of the congregation, and we thank them for their support.

The Prayer Shawl ministry continued at a steady pace in 2017. We blessed a total of 40 shawls, and distributed twenty-one. The recipients and their families greatly appreciate this ministry. It offers a great deal of comfort to people, and the response is overwhelmingly positive, as people feel it provides them with a tangible reminder of those who love and care for them, and remember them in prayer. We have many crafters who give of their time and talent, and donors who offer financial support for materials, and we are grateful to all of you. Thank you.

I am, as always, grateful for the constant and continuous support of my colleagues and the congregation. I truly love being here at Bethany, and I look forward to another successful year.

# **Community Engagement Ministry**

We are blessed at Bethany to have a group of dedicated, kind and caring and energetic youth! It is indeed a privilege to minister with this great group of young people. This past year has been a bustle of activity for the SKILLS children and Youth Group with Sunday night gatherings; a dedicated group of youth keen to be together in community. Some of the highlights for the youth this past year included a skating party on Chocolate Lake, board game night, and movie night, an evening with Barry Paton sharing his Spy adventure novel, preparing and selling Soup Mix Jars in support of Hope Cottage and an outdoor hike on Palm Sunday. The youth group made a very moving video based on the biblical story The Road to Emmaus which was shown at Jazz Vespers in April. The youth led this Jazz Vespers service through word, music and imagery based on the well-known folk tale Stone Soup. In May youth, parents, and members of the congregation participated in the Kairos Blanket exercise held in our Fellowship Hall. This interactive exercise focused on Indigenous relationships and our Canadian history. It was an educational and emotional experience for all. Many youth and parents gathered in late May to create a Community Vegetable Garden on the lawn next to the sanctuary. Raised boxes were built, soil was spread and seeds were planted all in a day's work! We planted kale, lettuce, beans, nasturtiums and tomatoes which were enjoyed over the summer months by the congregation. In June we met at the home of Dana and Jeff Mills for our year-end closing bonfire and outdoor games.

We reunited in September with a bonfire and kayaking on Chocolate Lake. Changes were made to the ages of both youth groups. SKILLS now Grades 5 – 7 and Youth Group Grades 8-12. This has been working well and the youth are comfortable with this change. Dana Mills was our guest one evening, with an interactive discussion on Orange Shirt Day/ Indigenous Reconciliation and the involvement of the UCC. The youth also assisted with the Fall Fair and Silent Movie Event and learned about Food Security and Food Sovereignty. In light of this the youth made healthy snacks and collected fruit from the congregation for the youth at Phoenix House as part of the Food for Phoenix program in November. A highlight for myself and the SKILLS group was visiting the home of Gloria Stephens in early December. The SKILLS kids greeted Gloria at her door with a robust rendition of Jingle Bells. The children were mesmerized with Gloria's festive lights and Christmas Village decorations. I hope this becomes an annual event! 2108 came to a close with our annual Old Fashioned Christmas in support of Phoenix Youth. The youth group led worship and presented a drama written by Kevin Little. Former youth group members Sean O'Brien, Hannah King and her husband provided beautiful music throughout the evening. Thank you to all!

The JOY Lunch program continues to grow in numbers as the hospitality of our Bethany folk spreads beyond our doors. Our Christmas luncheon served 80 people! Special guests have

included Marie-Claire Chartrand of Grey Wave Senior Care; Gloria Stephens on the evolution of nursing; Kevin Little on finding a purpose in retired years; Love Songs for Springtime performed by myself and Shawn Whynot; Lori Cormier shared her work with seniors at Melville Heights; Elizabeth and Bob Carter, and Ian and Mavis Hicks shared their trip to Vimy Ridge; Zenorah and David Rackham shared their memories of Christmas and New Year Celebrations in Japan. Special thanks to Tim Cormier for his time and culinary skills and all those who assist in the kitchen and at the door; Barry Paton for technical assistance; and Rev. Kevin, Rev. Vince and Rev. Elroy for their prayers and blessings at each gathering.

Bethany's indoor walking program **Walk and Talk** was implemented in January 2017. This program arose out of the congregational workshop held in October 2017 hosted by the Revelation Committee. Many seniors felt our building would make a great space for indoor walking during the winter months when walking out doors is not ideal. Each Wednesday morning a group of approximately 20 people enjoy walking laps throughout the building followed by coffee, tea, nutritious smoothies, crossword puzzles and conversation. Kevin joined us on the last Wednesday of each month, engaging us in a themed conversation. This program was so successful we resumed in November. HRM Community Health Team member, Jenn Manuel joined us for an initial introduction to health and wellness programs offered to seniors free of charge. She will be joining us once a month January —April as she shares with us her Ready, Set, Move program; educating seniors on how to stay physically active throughout each day. Kevin continues to join us on the first Wednesday of each month for interesting and enlightening conversation.

I would like to express my thanks to Kevin for inviting me to preside on Sunday mornings this past July while he was on vacation. 
Members of the committee are also responsible for organizing, setting up and managing the HOME DÉCOR section of the Annual Fall Fair.


# **BETHANY MEN'S CLUB**

# **PIERCEY MEMORIAL GARDEN COMMITTEE**

This committee was formed after the congregational meeting in 2016, under the chairmanship of Rev. Randy Crozsman. The mandate of this committee was to review the purpose of the garden and discuss ways that it could be renewed and rejuvenated.

After extensive discussion by the committee members, regarding the purpose of the garden, the following points were identified: it should be a peaceful place; it should be open and accessible to everyone in the congregation; elements in it should be moveable (if the church decides to change the configuration of the present buildings or move to another location); it should be easy to maintain; it should not be too expensive.

The committee spent some time in the garden, trying to work out how best to achieve these objectives. It was decided to hire a landscape designer to help with planning the space. Kelly Grant, from Bloom Greenhouse and Garden Center, visited the space with members of the committee, who explained what we were trying to achieve. We received a detailed plan from Kelly in June, 2016.

The next few meetings were spent discussing how best to go about implementing her plan. There were several items that needed to be addressed before any planting could be done. These included: a new lock on the door to the garden to prevent people from getting locked in; repainting of walls and window trim; placement of heavy duty plastic over the grass in areas that would be covered with pea gravel. Many thanks to the volunteers who accomplished these projects.

A budget was prepared using Kelly's plan, which included all aspects of the plan, i.e. new shrubs and perennials, garden soil, pea gravel, garden furniture and a rain barrel. An announcement was put in the bulletin asking for donations, either money or items, and an account was set up by the treasurer.

As Rev. Randy left Bethany in January, 2017, Linda Knechtel took over the chairmanship of this committee.

As soon as the weather was favourable, the garden development got underway. Many plants were donated – some as memorials – as well as comfortable chairs and small tables. By the end of July, the garden was useable.

There are still some items on Kelly's plan that have yet to be implemented, but we anticipate having those completed in 2018.

#### THE EARLE AND JANET REID SCHOLARSHIP FUND ("the Fund)


Under the provisions of his Last Will and Testament, Dr. Earle Reid generously donated to Bethany United Church the sum of \$100,000.00 to fund the Earle and Janet Reid Scholarship Fund ("the Fund). Under the provisions of his Will, Dr. Reid provided that the net annual income of the Fund be distributed annually by Bethany by awarding two annual scholarships to recipients attending a secondary or post-secondary educational institution who are active participants in church activities.

The funds were transferred over to the Community Foundation of Nova Scotia to invest on Bethany's behalf. CFNS is a public charitable foundation established by Nova Scotians for Nova Scotians which works with private donors to build the financial and providing the expertise to maximize the benefit to each of these funds. Since all of the funds of the CFNS are pooled and invested together the CFNS is able to keep investment costs low in order to maximize the benefit of each endowment fund. The monies in the Fund are invested in a balanced fund comprised of 60% equities and 40% fixed income. The CFNS charges an annual management fee of 1.77% for each fund and provides annual and quarterly reports.

Under the terms of Bethany's agreement with the CFNS, an Adjudication Committee consisting of three members of the congregation and a representative of the CFNS has been established to review all applications for the two annual scholarships and to recommend the two annual recipients of the scholarships as set out in Dr. Reid's Will and then to forward their recommendations to the CFNS's Board of Directors for final approval. Currently, the three members from Bethany who sit on the Adjudication Committee are Beth O'Brien, Nancy Dearn and Greg McConnell. The CFNS is responsible for promoting the Fund.

This past year (2017) the two annual scholarship awards were granted in the amount of \$2,000.00 each to Charlotte Moase (Bethany United Church) and Jacob MacFarland (Bethany

United Church).



### **DIRECTOR OF MUSIC**

It is with great pleasure to write my annual report regarding the Music Ministry programs at Bethany United Church for the year 2017. Bethany continues to be an active and thriving congregation with many individuals participating in the program offerings. All of this participation enhances both our worship experience and the sense of community that is such an important characteristic of the Bethany congregation. 
The Handbell Choir is our celebrated ensemble of ringers adding beautiful music to our services on a monthly basis. This choir also rings at high feast Sundays such as Christmas and Easter. The children that take part in this program enjoy a snack and social time, singing and musical activities, crafts, story time, and then play time in the gym. This choir will sing in church during the year and more specifically on Children's Sunday in November, Christmas, Easter, and other occasions. This year we have also collaborated with the children of the Sunday school program to involve them in the presentation of music during worship.

Jazz Vespers continues to be a viable monthly offering for not only for the people of the Bethany congregation, but for the wider community. I say this because we consistently have new guests and returning guests that enjoy attending this service. Jazz Vespers happens the last Sunday of each month from September – May. We are also fortunate and thankful for our musicians that provide leadership each month including: Alison King, bass, Sean Weber, saxophone, and Ray Roberts, percussion.
